- 4. The school should ensure the strong governance and management of its activities in way of comprehensive al quantifiable planning in way of curriculum planning, infrastructure, resources, physical education, sta development and other co-curricular areas.

The school should go through the provision of Affiliation and Examination Bye Laws and keep a copy the of for reference purpose and also advised to visit CBSE websites i.e. http://cbseacademic.nic.in/ http://cbse.nic.in/ for updates. The School is expected to see all circulars on these CBSE websites regularly.

etc. Further, school will provide adequate facilities for potable drinking water and clean healthy and hygier toilets with washing facilities for boys and girls separately in proportion to the number of students.

- 7. **Admission to the school** is to be restricted as per relevant rules of Examination Bye-laws and rule 2.4.5, 2.6. 7.1, 7.2, 8.4.2, 8.4.10 & other relevant rules of Affiliation bye laws.
- 8. The school is required to follow rule No.2.4.7 and 2.4.8 of Affiliation Bye Laws regarding Books and Quality Education.
- 9. The number of sections in the school are restricted to **48** as per number of sections reported by the IC and sh not be increased without specific approval of the Board. For increase in number of sections, the School sh apply online to the Board as per rule 15.7 of affiliation by e laws.
- 10. The school shall be solely responsible for any legal consequences arising out of the use of scho name/logo/society/trust or any other identity related to running of school affiliated to CBSE. The school shall all be liable to bear all legal charges incurred by the Board, if any, arising out of these circumstances.
- 11. The school must strive to promote conservation of environment on their campus through rain water harvestin segregation of waste at source, recycling of organic waste, proper disposal of waste including electronic wast use of energy saving and energy efficient electrical equipment, greening of campus, use of solar energe education and awareness amongst children on environment conservation and cleanliness etc.
- 12. The school shall submit their information through Online Affiliated School Information System (OASIS) as p details given in circular no. affiliation-06/2018 dated 24.04.2018. Link for OASIS is available on Board's websit www.cbse.nic.in.
- 13. The optimum Section teacher ratio of 1:1.5 as well as student teacher ratio of 30:1 is to be maintained to teal various subjects and school shall appoint qualified and trained teaching staff on regular basis as per provisions Affiliation Bye Laws of the Board.
- 14. Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Class X and Class > examinations from the year mentioned while granting affiliation/upgradation regularly without break or inform wireasons thereof in writing well in time about the non-sponsoring of the candidates.
- 15. Running of **coaching institutions** in the school premises in the pretext of providing coaching to the students f various examinations is not permitted by the Board. Strict action would be taken on defaulters.
- 16. The Manager and the Principal of the school shall be jointly responsible for the authenticity of the online/offlin documents/ information/data submitted by the School to the Board.
- 17. Apart from rules to be adhered to by the school as mentioned above for drawing specific attention of the scho authorities, the school authorities are required to acquaint themselves with all the rules contained in Affiliation Examination Bye-laws and circulars/guidelines/ notification issued by the Board from time to time. Any laxity following rules/instructions of the Board will lead to action against school as per Chapter 12 of Affiliation By laws-2018.

The school shall be responsible to comply immediately with the conditions mentioned in the grant letter and shalls o maintain record of certificates, compliances, data and other records/information and shall be furesponsible to produce all such records before Board when asked for, failing which necessary action shall taken as per Affiliation-Bye-Laws.
